

THE KIDS' TABLE TS AND CS

The Kids' Table service is free and first come, first served to the kids of dining customers of our partner venues. Every parent / carer will be required to read and agree to our Ts and Cs on arrival at The Kids' Table before their child is given a wristband with their parent / carer's mobile number written on it as an extra safety measure before taking a seat at The Kids' Table.

We offer the following activities for children aged 3yrs and older whose parents / carers are dining within the venue: drawing / colouring in / bead threading / arts and crafts / temporary tattoos supervised by DBS checked playworkers.

During busy periods we may need to limit the children's time at The Kids' Table so everyone gets a turn.

1. It is a legal requirement that any child using The Kids' Table is 3yrs or over & the team may ask for a child's date of birth. Space permitting, under 3s may sit at the table with their responsible adult present.
2. The Kids' Table will take all reasonable precautions to keep children safe but their responsible adult must remain ultimately responsible for their child. In the event of an accident, The Kids' Table Ltd and its team will not be liable for any injury.
3. The Kids' Table is not a drop off event, parents / carers must remain at the venue and check in on their child at least once an hour.
4. Our team cannot assist children going to the toilet. If a child requires assistance a parent / carer will be asked to return to help them.
5. Parents / carers must notify a Kids' Table team member if their child has any allergies or special needs.
6. The Kids' Table is an entertainment service, not a childcare service. During busy periods, if any children are being disruptive or demanding particularly high levels of attention from our team, for the safety of the full group, they may be asked to return to their parent's / carer's table.
7. If The Kids' Table is busy, the team will be unable to chaperone a child / children back to their parent / carer's table due to the need to oversee the remaining children at the table. Parents / carers must the team know whether they're not happy for their child to return to them unaccompanied, in which case the child must remain at the table until the parent / carer has returned or a Kids' Table team member has called the parent / carer to collect them if needed. (This does not apply if The Kids' Table is situated in a different room / floor. All children will be accompanied in this instance).
8. Scissor safety: The Kids' Table team cannot offer one-on-one supervision of scissor use. Parents / carers must notify a Kids' Table team member if their child is not confident with scissors and requires adult help.
9. Children are not permitted to frequently go back and forth between tables. Children who repeatedly try to leave The Kids' Table may be asked to return to their parent / carer's table. When not sat at The Kids Table children are the sole responsibility of their parents.
10. Children must return to their parent / carer's table to eat. Please do not bring food, drink (with the exception of a water flask) or alcoholic beverages to The Kids' Table.
11. Parents must inform a member of The Kids' Table team if their child cannot have a temporary tattoo due to allergies or any other reason.
12. Parents must add their mobile number to a wristband provided by The Kids' Table team and attach the wristband to their child's wrist in case the team needs to reach them. Parents / carers must leave their phone switched on with the screen visible ready to answer.
